- 1. Meeting was called to order at 12:05 pm by Mrs. Dorrian.

Approval of agenda items

Motion by Mrs. Dorrian to approve agenda and seconded by Mrs. Young. Approved unanimously.

#### 4. Approval of mental health plans

Dr. T explained the current RCSA mental health plan and updates such as BIMAS-2 screening for grades 3, 6, and 9; the various mental health providers from the community, and that each campus now has designated counselors on staff. Dr. T. recommended to opt-in to the District Mental Health plan if there is an option given to the charter schools, the board agreed.

Motion to approve the RCSA mental health plans and opt-in district plan if there is an option by Mrs. Dorrian and seconded by Mrs. Boswell. Approved unanimously.

#### 5. Approval of updates on employee handbook

Dr. T presented the updates on the employee handbook sections including reimbursement of RCSA staff for attending professional development seminars; prohibitions on substance abuse of any kind; visitor policies; unused sick days, and employee requests to serve as witnesses for student family matters.

Motion to approve updates to the employee handbook by Mrs. Dorrian and seconded by Mrs. Boswell. Approved unanimously.

#### 6. Approval of budgets

Dr. T and Mr. Ozturk presented the 2018-19 final and 2019-20 projected budgets and changes since the June 2019 Board Meeting.

The M/H campus had a summer expense that was previously budgeted for the 2019-20 SY that was requested sooner than anticipated. This expense resulted in a deficit for the 2018-19 SY, however the fund balance contains sufficient funding and there is no impact to operations.

All remaining campuses have surplus financial results for the 2018-19 SY.
